
# Special Healthcare Needs Program





#### Special Healthcare Needs (SHCN) Program

A new program for employees and dependents with special healthcare needs designed with the following goals:

#### **Improve Access** to Care

Customers with SCHNs require access to a professional dental team with experience and expertise as well as access to a dentist who provides care to those with SCHNs.

#### **Improve Outcomes**

Lack of preventive and timely therapeutic oral care may increase the need for more costly care and exacerbate systemic health.

#### **Increase Satisfaction**

Tailored solution for those with SHCNs designed to remove financial barriers to care and improve access and outcomes, driving overall satisfaction.

#### **Understand Need**

Employees & dependents with SHCNs are unique and may require specialized, multidisciplinary oral care. Additional dental visits and time may also be necessary.

#### Offer Education & Resources

Cigna is developing anticipatory guidance for customers and caregivers as well as educational materials for dental providers.

#### Enrollment SHCN Enrollment Form

Eligible customers or their caregivers may complete a Special Healthcare Needs Enrollment Form.

Once the form is processed and the customer is enrolled in the program, a "Welcome Letter" will be mailed to the customer.



#### Activation and plan use Enhanced dental benefits and reimbursements

- Once enrolled, the customer visits their dentist to obtain care.
  - Coinsurance, copayment and/or deductibles are payable at the time of service.

In-network dentist submits claim to Cigna. (If dentist is not in-network, the customer may need to submit a claim).

Cigna processes the claim according to traditional plan benefits then the new SHCN program.

Eligible reimbursements mailed directly to customer.

### **Special Healthcare Needs Program Details**

Eligible Customers: American Academy of Pediatric Dentistry (AAPD) defines special healthcare needs as "any physical, developmental, mental, sensory, behavioral, cognitive, or emotional impairment or limiting condition that requires medical management, healthcare intervention, and/or use of specialized services or programs."
